# **Upgrade Letort and Big Spring**By David Stone

The Department of Environmental Protection (DEP) has proposed rulemaking to the Environmental Quality Board (EQB) to upgrade to High Quality (HQ) status a section of Letort Spring Run (from the Railroad Bridge at Letort Park to the Post Road Bridge and a section of Big Spring Creek (from T333 to Nealy Road). These are two of 50 stream upgrades in the Commonwealth. These sections had been previously designated as Class A by the Fish & Boat Commission but DEP had not elevated their water quality status. The elevation to HQ status creates further protections against water quality degradation by pollution and effluent discharge. Importantly, development projects in HQ watersheds must comply with more stringent permitting requirements that require a significantly greater buffer zone.

All comments must be submitted prior to April 18, 2016.

# Youth Background Clearances By Jeb Betar

Many of CVTU's youth programs and activities will be ramping up in the next several This is a reminder that any CVTU months. member must obtain a PA Child Abuse History Certification from the Pennsylvania Department of Human Services before he or she can volunteer their time to support CVTU's Youth Programs. A copy of the certification must be provided to me, as I maintain CVTU's list of cleared volunteers. The process for volunteers who have lived in Pennsylvania for at least 10 years is twofold: obtain a PA State Police criminal history check. and request a Child Abuse Certification from the PA Department of Human Services. process is free, however if a volunteer has not resided in Pennsylvania for at least 10 years, the volunteer will have to submit to FBI fingerprinting as a third step in the process and there may be a fee associated with the FBI action. I have the latest information, web sites, and procedures and can assist any member who would like to volunteer and needs the certification. If any member has questions or wants to verify whether he or she has the required clearance, I can be reached at (571) -643-8101 or via email at jebbetar25@gmail.com.

# Chapter Fishing Trips By Dave Weaver



### Fly of the Month **Modified San Juan Worm** By Dave Weaver

Many fly fishermen regard the venerable San Juan Worm (SJW) as really nothing more than an attractor fly that appeals only to dim-witted stockies. This is an unfortunate and inaccurate view. During my seining efforts on Letort and other Cumberland Valley streams I've noted prevalence of aquatic worms. Wild trout and stocked trout target these worms as well as earthworms that find their way into the water during the common high water events during early spring. The naturals are usually in the light reddish rust to pink or brownish color tones. My preference for SJWs is light pink or flesh color. In darker or deeper water, I'll use a brighter pink or red.

In my view, the main problem with the conventional SJW is the manner in which it is tied involving a hook in the middle of a length of chenille. Too often, the forward part of the chenille simply gets bent back into a "V" shape after a few casts. I prefer a modified SJW utilizing a curved shank hook. In this case, the SJW is tied on a "swimming nymph" style curved hook, although any curved style will work (or you can bend a long shank). The reason for the curved shank is to provide a nice, natural curve to the worm's body and allow you to avoid the extended length of chenille in front of the eye. More importantly, the curved shank enables you to tie the fly so that it drifts hook upward. Since SJWs often work best in the heavy flows of early springtime, you want this fly right on the bottom and if it drifts hook upward, you'll get fewer snags. The curved shank will enable this if you tie in some weight right at the bend. This weight at the bend functions as a lever that swings the fly into a hook upward position. To do this with the SJW shown below, you will want to put some lead wire at the bend, wrapped over the chenille.

The first step to tying this fly is to wrap a base of thread the length of the shank. Next, palmer some thin thread (I like clear mono) through the chenille up to the eye and finish the head. I find a couple tiny drops of Superglue really help position the chenille on the shank. The next step is to tie about a dozen turns of thin lead wire over the chenille right at the deepest part of the hook bend. Finally, wrap a contrasting color thread, such as deep pink or red, over the lead wraps to seal them down and provide a nice looking collar on the worm. Having a bright collar looks natural and the brighter color perhaps helps trigger strikes much like hot spots on nymphs are

thought to do. I really like this modified SJW and find it gets trout year round. In particular, this fly fished as a dropper with a stonefly nymph combine to be my go-to set up for nymphing in the early spring months.

HOOK: Any curved shank hook that matches the size of the worm.

BODY: White or pink thread underneath pink chenille, secured with turns of clear thread. COLLAR: A dozen turns of lead wire covered with red thread. Coat heavily with cement.
