Thinking Like a Watershed By Dave Weaver


When you're traveling around the Cumberland Valley, do you ever wonder where you are? Well, sure, you've got GPS, or an old school map. Maybe you just know the area by heart. Well, as lovers of trout streams, we may also care to know where we are with respect to watersheds. Other folks may think in terms of townships or counties or school districts. We think in terms of trout streams. As the popular current commercial goes, "it's what we do." Oftentimes, when I'm driving up or down I81 or RT 174, I'm wondering what is the nearest stream? Where does it flow? It's easy to know if you're in the Breeches or Conodoguinet watershed, but what about being more specific? Everywhere you look out your car window, there are tiny creeks and drainage areas. Where do they go? Am I in the Mountain Creek watershed, or perhaps Old Town Run. Where I live in Adams County, we even have something of a big river divide in that about half the county flows into the Potomac and the other half the Susquehanna. The Cumberland Valley isn't quite so stark a demarcation, but it's fascinating to think about. At any given time, where are you with respect to first to third order streams and where do they flow? This is the first step toward a greater consciousness about storm water runoff, riparian zone impact, and potential point source pollution. It's also a natural way, for those of us who love streams, to consider the landscape around us. The stream I just drove over flows into this stream, and this stream into that stream....Call it "thinking like a watershed."

Cold Water/Hot Topics By David Stone

Susquehanna Update: Pa's Department of Environmental Protection once again has declined to list the Susquehanna River as impaired. DEP continues to acknowledge the river's health problem but by not recommending that the river be listed as "impaired", no cleanup timetable is imposed and no federal dollars will likely be designated to assist in any cleanup. John Arway, the Executive Director of the Fish and Boat Commission, is disappointed in the decision but continues to push for the impairment designation. See link to DEP press release for details:

Ed Shenk Wins Award By PA Fish and Boat Commission

The Pennsylvania Fish and Boat Commission (PFBC) presented legendary fly tyer, fly fisher and author Ed Shenk, of Carlisle, PA, with its Pennsylvania Angler and Boater Confluence Award at its July 2016 Quarterly Commission meeting in Harrisburg.

Shenk, long associated with the Letort Spring Run, has written 62 articles for publications such as the Pennsylvania Angler and Boater, Sports Afield, Field and Stream, Fly Fisher, Fly Fisherman, Fly Fishing Heritage, Fly rod and Reel, American Angler, Fly Tyer and the Mid-Atlantic Fly Fishing Guide. He also authored the book, Fly Rod Trouting in 1989 as well as a VHS video in 2000 and released as a DVD in 2013 titled, "Ed Shenk, Master of the Letort." He also has made many personal fly fishing instructional appearances including at the Fly Fishing Shows. Shenk has been inducted into both the Catskill International Fly Fishing Hall of Fame and the Pennsylvania Fly Fishing Museum Hall of Fame. He also served as the first President of the Cumberland Valley Chapter of Trout Unlimited sharing the position with well known angling author the late Jim Bashline.

Shenk was nominated for the award by PFBC District 4 Commissioner and professional outdoor writer Lenny Lichvar, who also generated the concept for the award several years ago. Previous winners of the award include fly fishing author Charlie Meck, who was also nominated by Lichvar, and long time Pennsylvania outdoor writers Bob and Linda Steiner.

Cramer Project By Dave Weaver

In late August, your chapter completed the Yellow Breeches work project on the Cramer property in South Middleton Township. This stream section is located at 330 Old York Road (RT 174) near the intersection with Zion Road. As usual, kudos are due to Don Albright and the FITS crew. Gleim Environmental did the heavy machinery work. The stream project included mud sills and wing walls. These structures improve fish habitat while reducing erosion and sedimentation.

Susquehanna Impairment By Dave Weaver

The following comes courtesy of Dick Martin of the Forest Coalition:

The River needs your help. The past five DEP Secretaries have said "we will follow science for this decision." Sadly, science usually takes a back seat when lobbyists and politicians get involved. Based on solid evidence, scientists have identified the causes of the drastic decline in smallmouth bass on the Susquehanna River as most likely EDC's (Endocrine Disrupting Chemicals) and herbicides along with other stressors. The use of herbicides, such as Roundup, have increased 250X in the past 40 years. The World Health Organization found that this herbicide is probably carcinogenic to humans and it is banned in a number of countries, but not the USA. Comment now to DEP.

Fly of the Month JAA - "Just Another Ant" By Tom Miller

When summertime rolls around and our reliable spring hatches have run their course, it's terrestrial season! And terrestrial season continues into the fall. My go-to terrestrial pattern year in and year out has always been a simple black ant. I've had some of the most amazing takes and rises to just plain good old black ants. I'm sure they must taste like Bon Bons to those trouts. I like to fish bigger ants unless working a particular sipper, so you'll mostly find #12s and 14s in my boxes. This is one of the variations. As pictured, it's tied with an orange wing, mostly for you and me, and not the fish. You can also tie it with a natural CDC puff for a more traditional "flying ant" look (or skip the wing, and squint more while fishing). I like the curved hook for the profile it presents in the film. It's also different and maybe something a bit quirky that that particular fish hasn't seen yet.

Tying this "JAA" is simple enough: work the proportions and start with a dubbed ball at the end of the bend of the hook, then just a thin waist of thread before tying in a single CDC puff for the wing at about the mid-point of the hook. I usually shoot for five wraps of hackle in front of the wing and then finish with another ball of dubbing at the head. Whip it and you're done. Good luck!

HOOK: Dai-Riki #135 Scud Hook

THREAD: Black

DUBBING: Black Muskrat

WING: "Sulphur Orange" CDC Puff

HACKLE: Black
