Vice President, Justin Pittman: Pittman attended Kettle Creek Watershed banquet and talked to April Wolf about tree cutting efforts in northern tier of the state. She mentioned high priority areas for streams such as Kettle Creek, Pine Creek and others. He asked what some of the reasons of having grant funding denied. She said getting grant money will probably take some creative thinking due to the state/grant funding going towards the higher priority areas. They are seeing

those higher priority watersheds being larger along with the tributaries compared to the Breeches and such.

J. Zazworsky mentioned the Coldwater Heritage conference having some funding options but probably competitive as well.

Leone brought up the Letort fish kill and the fine that was imposed. Sunday did say the contractor was levied the fine but doesn't know if the fine was collected by the DEP. He'll look at seeing who the contact might be for checking on the status of that.

There are still some items from the online auction as well as some other things that could be used at the Family Picnic event in Aug. Pittman will make a list of what is available and rounding up some things for the event. Sunday is planning on running the fly contesting contest again with gift cards from TCO and Precision for the winners.
