- 5. Stream Access and Conservation Committee, Neil Sunday:
 - Posting of Lower Letort After the board meeting, Zazworsky received an update on recent posting of property from Carlisle Pike to the mouth. Dave Stone is maintaining contact with landowner. Stone will arrange meeting between Zazworsky and landowner

- to explain CVTU concerns with erosion and how the project will address erosion, with the intent of gaining landowner support for the project.
- FITS (Sunday) 1st raking event occurred on September 13 with some raking done but needed to remove a fallen tree that was jammed under the bridge. Sunday has 2 dates upcoming for spawn bed raking at the Letort with a possible additional date as needed -September 20, September 26

Pittman mentioned that there is a fallen tree at Shady Lane on the Letort. Also proposed drafting a letter to the PFBC requesting a meeting to discuss the Yellow Breeches fishing access/stocking in the Craigshead House area.

Daniels mentioned that we have a deed for the Heritage Tract but Betar will review to confirm. Baltz suggested we should package our efforts on the properties we do own and prioritize the efforts based on the levels of participation. Zazworsky asked if Sunday would get some things together from a Stream Access and Conservation Committee perspective with Board input on a "top 5/top 10" things to do with our current properties in terms of conservation/improvement efforts. Sunday said to send him the work ideas for our properties and then he'll consolidate the input and present at the next board meeting. Naguski mentioned that we need to make sure of the pesticide legality on our properties, as well as applicator's license, liability for pesticide applications, liability for burns and chapter 105 permitting for both in-stream wetland and riparian work. We need to make sure we are compliant regarding these.
