## 6. Stream Access and Conservation Committee, Neil Sunday:

- FITS (Sunday) no in stream work for now; there is some spawning activity below the barracks
- Barnitz Project Update John Leonard working with Cumberland County Conservation
   District to seek additional grant money; Meeting with South Mountain Partnership
   regarding the grant and releasing of funds
- Update on Restoration of Vince's Meadow and Adjacent Heritage Tract Properties Greenlee is assembling inputs from board members to establish board-approved work
  priorities; Zazworsky suggested we incorporate riparian work events into a calendar for
  2023; Sunday suggested that it may be good to coordinate some same dates in 2023 to
  have maybe larger turnout and to allow for volunteers to pick between being doing in
  stream work or land-based work;
- Wittlinger Preserve Tree Planting October 23 (Daniels) plantings are done for the year
  and now we need to maintain the property to make sure the area around the plantings is
  clear of weeds/plant growth; Naguski said there may be some money available for buffer
  work but is probably more along grant applications and thinks it's open without any
  deadlines. He'll take a look at getting more information on that.
- Proposed Chapter Purchase of Chain Saw & Support Equipment (Leone) discussed the
  possibility of purchasing a chainsaw but at this point we'll continue to rely on volunteers
  to bring needed tools for cleanup work although there are some tools that are available in
  the shed at Vince's Meadow
- Issue with property adjacent to Charlie Fox property on Letort (Sunday) there is a
  dismantled vehicle/RV by the stream; he is asking for a CVTU letter of support to be
  written to South Middleton Township regarding the neglect of the property and the
  possible discharging of liquids/contaminants into the Letort. Zazworsky suggested we
  should send a copy to the Letort Regional Authority (LRA). Sunday volunteered to draft up
  a letter for review

# 7. Information and Education Committee, Garrett Kieffer:

- Web site status (Golla) she just got the username and password for admin access and
  will then assess what needs done; domain name expires in Dec 2022 but has an automatic
  renewal so the site should continue to be up and running; Zazworsky said we'll need to
  decide if we want to maintain the site ourselves or have a commercial vendor maintain it
  but Golla will take a look at everything and see what is involved and we'll go from there
- Fly tying class (Daniels) was looking to hold them on Mondays but South Middleton couldn't accommodate that; he looked into Carlisle Community Center – they have

Mondays available and there would be a 70/30 split on revenue, which is more favorable than South Middleton; Daniels moved to hold the fly tying classes at the Carlisle Community Center and to charge \$50 for the experienced class and \$30 for the beginners class, Naguski seconded the motion and the board approved the motion without objection

 PA American Water – Daniels & Zazworsky met with External Affairs Manager on November 7; potential source of grant or scholarship funds; need to develop plan to meet their annual application deadlines; contact information relayed to Rivers Camp and Doc Fritchey chapter; we'll be adding them a list to groups that we work with

Request for Letter of Support (Grant Application) Ben Mummert, representing Letort Stewards volunteer group, is applying for county Land Partnership Grant & has asked CVTU for letter of support; see attached documents for background; Naguski and Baltz brought up concerns regarding trees in the streams, supporting only land based work (nothing regaring stream work), the use of pesticides and any work needs to be in alignment with the Letort Coldwater Conservation Plan. Zazworsky will revise the letter to include issues/concerns that were mentioned and will send it out to the board for review within the next few days for concensus/vote
- **13.
